# **Corn Exchange news**

The Corn Exchange in Wallingford has been awarded a total sum of £40,700, (payable in three stages) from the government's Culture Recovery Fund. This fund was set up to ensure that arts venues are able to continue operation despite the current Covid pandemic.

The award was made by the British Film Institute on behalf of the Department of Culture, Media and Sport and reflects the association between the BFI and independent cinemas through the Film Audience Network.

The Corn Exchange is a member of the FilmHub South East network and thus has access to a wide portfolio of British, independent and foreign films.

The BFI grant is a lifeline for the Corn Exchange and will ensure that the new season in 2021 starts on a positive note with sufficient funds for the venue to continue operating safely and comfortably.

# **A Very Personal Nativity**

At this time of year every parent or grandparent will have fond memories of their children or grandchildren performing in a School Nativity Play. In December 1949 St John's Boy School produced a series of sketches and a nativity play at the Masonic Hall.

It was late September when the parts were cast. I had no hope of getting into the choir as, only a year before, the Reverend Gobbit told my parents that my two weeks in St Leonard's Choir would have to come to an end as I could not sing, and I was putting off the other choir members. But I hoped for a part in the nativity play.

I thought one of the wise men was beyond me but a shepherd or an angel was attractive. Miss Nash, the director, began to name the cast, Alan Pemberton was given the role of the Angel Gabriel, Billy Batten and Tony Morris were two of the Kings, Richard Lay was the Innkeeper, and Peter Shayler was his wife.

I thought, "she hasn't named Mary yet" - and then her steely gaze fell on me. I can still remember her words, "Beasley you will play the Virgin Mary", and then she laughed and so did the rest of the class. To make matters worse she told me to come down to her house sometime in the next two weeks so my dress could be altered.

For the next month we learnt our lines. Dress rehearsal followed; the white piping that had been added to my dress was thought to be extremely attractive, a view I did not share. The costumes were very good and had been made before 1914.

It was decided that the National Health glasses that I wore would not look right on Mary, so I had to remove them. But the opening scene was the Angel Gabriel visiting me on a darkened stage. Getting to my chair in the dark, without my glasses, was a problem and I walked into the chair and knocked it over, an act that Miss Nash didn't forgive for some time.

On the night of the performance, over 300 parents, relations and friends crowded into the Masonic Hall. John Atwell did the make-up of us boys, he put lipstick on me which I wasn't that happy about. The play went very well, and we had a good write-up in the B and O newspaper.

That was my one and only stage appearance as I didn't want to be type-cast. I must also thank Richard Lay for not telling anyone of the part I played in the nativity play.

## **Parish Council notes**

Crowmarsh Parish Council met on-line on Thursday 10 December.

**Present:** Cllrs John Griffin, Stephen Sherbourne, Andrew Johnson, David Rowley, Ken McCrea, Robin Smith, Stuart Soames, Fleur Stevenson, Liz Ryall and Julian Park, Dr Yvonne Peet (Finance Officer) and Mrs Sue Rance (Clerk). Apologies were received from Cllr David Topliss and District Cllrs Cooper and Powell.

The council still has one vacancy and would welcome expressions of interest: please contact the parish clerk.

Mrs Elizabeth Burnell, a director of the Residents' Association of Bellamy Way and Stephens Field, addressed the meeting on the long-term problem of inappropriate parking in Stephens Field and the road to the Riverside Park. Vans parked overnight for a period have been reported to the County and District Councils. The Chairman will ask the County Council again to implement the parking restrictions agreed following last year's survey and to close the old access road.

### **District council matters**

District Councillors were unable to join the parish council meeting because they were attending the full District Council meeting to discuss adoption of the controversial South Oxfordshire Local Plan (LP2035).

SODC officers are working intensively with colleagues from the County Council, Public Health England and the NHS to plan for mass testing and mass vaccination of the local population. Residents are encouraged to contact the Community Hub if they need help with access to food, or to claim the £500 grant if instructed to self-isolate. The SODC Community Hub team is available from 8.30am-5pm Monday to Thursday, 9.30am-4.30pm on Fridays. Call 01235 422600 or email communitysupport@southandvale.gov.uk.

SODC is taking responsibility for managing on-street civil parking enforcement in collaboration with the County Council during 2021, alongside their existing off-street parking enforcement powers.

Your responses to the residents' survey about possible use of the former SODC site on Benson Lane are being analysed and will be reported to the next parish council meeting.

### **Planning**

The proposed development at Newnham Manor is due to be considered by the SODC Planning Committee on 26 January.

A meeting has been arranged between residents, Bloor Homes and the county and parish councils to discuss highway works in Benson Lane.

<u>P20/S3889/HH</u> 27 Benson Lane Crowmarsh Gifford OX10 8ED. Ground and first floor rear extension. Planning permission

<u>P20/S3870/N1A</u> 55b The Street Crowmarsh Gifford OX10 8EA. Conversion of office to 2-bed residential property. Permitted development, but without the proposed new window to the south facing elevation.

<u>P20/S3537/HH</u> 4 Whitehouse Road North Stoke OX10 6BA Demolition of existing conservatory; two storey side and rear and single storey front and rear extensions. Planning permission.

Responses to consultations

<u>P20/S4150/LB</u> Carmel College gateway. To widen the access, deconstruction of piers 3 and 4 is required as well as the rebuilding of dwarf walls C & D. No objection but rebuilding must be according to the earlier planning permission and the conservation officer's requirements, using

appropriate materials.

<u>P20/S4518/FUL</u> 'The Sycamores' Land east of 206 Crowmarsh Hill Crowmarsh Gifford OX10 8BG. Erection of five dwellings and associated works as phased development. Plans have already been agreed, and there is no objection to the work being phased. Members questioned whether RAF Benson had been consulted.

<u>P20/S3849/HH</u> 84 The Street Crowmarsh Gifford OX10 8ER. First floor extension on top of ground floor utility room to increase size of 1st floor bathroom. No objection.

<u>P20/S4163/HH</u> 53 Newnham Green Crowmarsh Gifford OX10 8EP. To demolish existing garage to west and erect a two-storey extension. No objection, but comment questioning alternative parking provision.

<u>P20/S4178/FUL</u> The Old Walled Garden Mongewell Park Mongewell OX10 8DA. One for one replacement dwelling (of implemented house). The five houses were conceived as a set of 5 (see <a href="http://carrollandpartners.co.uk/project/wall-house/">http://carrollandpartners.co.uk/project/wall-house/</a>) but assuming no wasteful demolition of an existing building, there would be no grounds for objection.

A meeting has been arranged between residents, Bloor Homes and the county and parish councils to discuss highway works in Benson Lane.

## Neighbourhood plan

The Crowmarsh neighbourhood plan has now been submitted to SODC.

#### **Finance**

Payments approved included £1620 to Carroll & Partners for building regulations fees and construction drawings, £720 for the external audit, £1980 for three days' consultancy to prepare the neighbourhood plan for submission and £3000 for a survey and preliminary design of a pedestrian crossing in The Street near The Bell. £676 had been received in November from the feed-in tariff for the solar panels.

The audit report is complete and no issues were raised: the report and accounts are available for inspection.

The draft budget for 2021-2 had been circulated based on a precept of £39,605, which will keep council tax charges at the same level. After discussion, the budget and the precept were agreed.

The budget was considered in the light of a year when income has been reduced because of the closure of the pavilion, although tennis income has increased. The budget for the year predicts an overall deficit of £5367. This includes £50,000 for pavilion improvements, £10,000 for sports equipment and replacing the floodlights on the hard-court area with LED ones, and expenditure on safety measures, with further income expected from developers through the Community Infrastructure Levy.

We will review the budget every quarter in the light of the considerable uncertainties. The Finance Officer was thanked for her clear budget presentation and sound advice.

### **Environment and recreation**

The architect will apply for building regulations approval for the planned improvements to the pavilion and a structural engineer will be engaged.

It is hoped to fit a safety net for the climbing equipment and a barrier to prevent large vehicles entering the car park. Repairs to the roundabout and the train will be carried out early in the New Year. Biomisting of the play equipment has continued.

A resident has expressed appreciation of the facilities at the playground that enable disabled children to participate fully.

## **Traffic and transport**

The council agreed to support the '20s Plenty for Oxfordshire' campaign to reduce the speed limit in towns and villages to protect pedestrians and cyclists.

The replacement bus shelter is now in place near the Crowmarsh roundabout on Portway. A new name plate has been installed in Church Lane, North Stoke.

The Chairman has submitted a proposal for improvements to Watery Lane to the County Council and the Ridgeway Trail Officer, for costing and assessment.

### Other matters

Street lighting in North Stoke has not yet been replaced with LED lights as promised.

Councillors were encouraged to participate in online training courses. The chairman had attended an online meeting of the Oxfordshire Neighbourhood Planning Alliance.

The Bell public house, which is a listed building, has been closed since March. It was agreed to write to Greene King enquiring about their future plans for the pub.

There will be speed restrictions on Portway for installation of cables between 26<sup>th</sup> February and 1<sup>st</sup> April 2021.

## **Next meeting**

The next Parish Council meetings will take place online on Thursday 14<sup>th</sup> January and Thursday 4<sup>th</sup> February, starting at 7.30pm. Please contact the clerk if you wish to join a meeting. Dates for meetings in 2021 were approved, mostly on the first Thursday. We expect to meet online until June.

## The Vicar writes...

It seems our main hope for 2021 is for the COVID vaccination. I've spoken to many people who are awaiting the phone call that tells them when theirs is due. The pandemic has affected us all, mostly affecting our quality of life, but it is the potential reduction to our quantity of life which frightens us the most. This is why we accept the lockdown restrictions and their impact on the economy and our own wellbeing, because we do so out of love for our neighbour and those working in the NHS, to protect them from a premature death ...or even a "mature death" as it is the elderly who are most affected.

So, using the same logic, what are we prepared to give up for an eternal life? It should be everything, right? All else is ultimately expendable: our wealth, job prospects, way of life and even deeply held family traditions such as the way we spend Christmas. The good news that the church proclaims is that God offers us a vaccine against death itself. This cost a huge amount to bring about but it is freely available and offered to all. Now, that may seem too good to be true - it is natural to have questions: Is it safe? How effective is it? What are the side-effects? Who has gone ahead of us in the queue?

To answer these in reverse, Jesus was first in the queue and has proven it works. It works because it was God's plan all along and he knows us more intimately than even those who can decode our genome – God our creator knows our problems, our deepest needs and most importantly he knows the solution – God's own self-sacrifice is the only solution as he alone represents both absolute justice and the absolute love that forgives.

So, what about the side-effects? Is it safe? Well, actually... "No".

To follow Christ is the way of the cross - it stands against the worldly values which rely on the exploitation of fellow humans and of creation. His followers may expect persecution, ridicule and disdain. In some societies, following Jesus can mean actual persecution, false accusations, rejection by family, denial of basic rights and being last in the queue for state aid during this pandemic. Ironically, those who turn against the tide are called "sheep" but it takes a brave sheep to follow Jesus and his teachings. But if there is "herd-immunity" it is to be found in his flock that self-identifies as the church – here his life-giving Spirit rules. The vaccine of ultimate salvation is available to all and brings real comfort and joy even in these dark times.

It was lovely to be able to worship together in church over Christmas and on 27th December. However, with the new strain of coronavirus rapidly spreading despite the existing Tier 4 restrictions and increasingly present among our own friends and neighbours, we are advised to stay at home until the situation improves. ## From John Howell MP

As I write I am mindful of those whose loved ones have died prematurely at the hands of the virus and those who have suffered in other ways too. I doubt many people have come through the situation unaffected in some way or another. As we turn the corner into a new year, and with one vaccine already rolling out and others potentially close behind, let us hope that as 2021 progresses we will be able to return to a more normal situation.

Whatever their political view, during the course of 2020 many people told me that they did not envy the Government having to make decisions about how best to deal with the COVID crisis with the many different issues to be considered. Whatever decisions were made there were some people who were unhappy – some wanting tighter restrictions, some wanting greater freedoms; and whatever financial support measures were introduced there were some who felt they were too little and some who felt they were too much.

During the year The Speaker did much to keep parliament moving and enable business to carry on but inevitably it has been slower than usual with remote working. Debate was also curtailed to some extent with limited numbers of MPs allowed to be in the Chamber at any one time and so the usual pattern of discussion with interventions was limited. For some time there were also no Westminster Hall debates. This is where MPs can raise specific shared concerns for debate and reply by a Minister.

In all of this it has been difficult to move as quickly as the Government would have liked to act on election manifesto promises. The opportunity to bring things forward was hindered by the more urgent issues. Some things will still come forward but more slowly, and others may need refocus in the light of the experiences of 2020. It is my hope that in the year ahead we will be able to focus on some of the important issues that have been leapfrogged by COVID. I hope too that I may be able to get out and about more to meet people in the constituency in business and in the community as I have in other years. Although technology has enabled us to keep some contact going as human beings there are times when there is no substitute for meeting face to face. However some of the benefits of using technology in ways we had not previously discovered must not be lost. I will continue to use online meeting facilities where it is more efficient to do so. I think we have all learned to be adaptable and must harness new opportunities.
