Advice from the Parish Council during the Covid-19 lockdown

As we begin to get out and about more, social distancing could be harder to achieve, but it is still necessary to stop the spread of the coronavirus. The county council is working with towns and parishes to make more space for walking and cycling to enable safe distancing.

Cycling on the pavement over Wallingford Bridge is illegal and antisocial. It makes social distancing difficult. Do not cycle on the pavement: use the road. If you feel unable to cycle on the road, push your bike across the bridge and keep a safe distance at all times.

Recycling Centres Open

Oxfordshire County Council re-opened Household Waste Recycling Centres on 18th May, for essential use. This means waste that cannot be stored at home or would cause harm to health if stored.

There are new site rules to ensure social distancing and the safety of residents and site staff. Opening hours are reduced to 8am – 4pm to allow for cleaning. There are limits on the number and size of vehicles allowed in and only contactless payments are accepted.

Queues are likely, so if your waste can be disposed of legally and responsibly in another way, such as weekly kerbside collections or district council collection services, please use that service instead.

Use new fast-track reporting for suspicious emails

Scam emails are becoming so smooth and sophisticated that even computer experts can be deceived by them, and the rest of us are in constant danger of being taken for a ride.

There is no need to feel isolated with the problem, though. If you are suspicious of an email or simply unsure, don't open the email and don't click on any of its links, but forward it right away to a new, dedicated reporting service which is very quick and convenient: forward the email to report@phishing.gov.uk and the National Cyber Security Centre (NCSC) will investigate it.

Past Times

The Sale of the Mongewell Estate

At the end of August 1918, just as the First World War was drawing to a close, the outlying portions of the Mongewell Park Estate were auctioned off by Messrs Simmons and Sons at Wallingford Town Hall. There was a very large attendance at the sale and the bidding was so keen that all the lots, with one exception, were sold very quickly for high prices. The mansion and park had been sold previously by private treaty to Mr Gould, an American millionaire, with the intention of converting it into a hospital for wounded officers. The first lot, Newnham Farm, which had river frontage, sold for £5300 to Mr Flack. Lot 2 comprising of Dorrell's Farm and Bennett's Barn with an interesting Elizabethan house, sold for £500; Mr Molloy purchased the lot for Mr Gould. Sheepcote Farm was Lot 3, consisting of some 207 acres, and Mr H Wigley was the successful bidder, at £3000. Lot 4 was 52 acres of arable land between Newnham Farm and Sheepcote and was purchased by Mr John Edwards. Woodhouse Farm was the fifth Lot and the bidding was very fierce, Mr Williams being the successful bidder for a price of £9300. This lot included the six cottages known as Forest Row. Mongewell House was used as an officers' hospital until January 1920, when it was closed at very short notice. All the patients were moved to a hospital in Brighton within a week and the house was converted back into private use. Mr Gould lived here until 1939 when he and his English wife returned to America.

Crowmarsh Parish Council met on-line on Thursday 4th June.

Present: Cllrs John Griffin (Chairman), Stephen Sherbourne, Stuart Soames, Ken McCrea, Fleur Stevenson, David Rowley, Andrew Johnson, Julian Park and Liz Ryall, District Cllrs Andrea Powell and Sue Cooper, County Councillor Mark Gray, Dr Yvonne Peet (Finance Officer), Mrs Sue Rance (Clerk) and one member of the public. Apologies were received from Cllr David Topliss.

The council is getting used to meeting on Zoom. James Penney, a local resident, joined us to speak in favour of the revised planning application at The Springs in North Stoke.

There is a casual vacancy following the resignation of Cllr Jon Grove. Please contact the parish clerk if you might be interested in joining the parish council. Residents of North Stoke or Mongewell are especially welcome to apply.

District and County Council reports

SODC's Community Hub has been extremely active in supporting vulnerable residents over the past couple of months, but activity levels have now started to reduce.

Car parking charges were due to be re-introduced in SODC-owned car parks from 8th June as some shops and other facilities reopen.

Planning consultations

P20/S1589/FUL The Springs Golf Club, Wallingford Road, North Stoke OX10 6BE

Re-submission of application P19/S1536/FUL including part-demolition of the more recent former hotel building, a replacement green keeper maintenance building, extension to the clubhouse and 33 holiday/hotel lodges. NO OBJECTION subject to retention of the original hotel building and significant measures to compensate for additional traffic through North Stoke, to include a pedestrian crossing and other traffic calming and one or more speed indication devices.

P20/S0465/HH 1 Newnham Farm Cottages, Old Reading Road, OX10 8BW

Two-storey side extension and single-storey rear extension. NO STRONG VIEWS but comments about the height, bulk and design of the side extension as viewed from the public bridleway.

P20/S1878/CHR CALA Homes site, CABI, Nosworthy Way, Mongewell OX10 8DE

Extension of operational hours between 06:30 and 19:00 for at least 6 months. No OBJECTION.

Strategic priorities

Money from the Community Infrastructure Levy will allow the council to proceed with some infrastructure improvements. The pedestrian and cycle crossing of the A4074 Portway is included in the planning application for development on the Newnham Manor site. Cllr Sherbourne will contact Peter Brett Associates to draw up a design for a pedestrian crossing in The Street near to the Bell pub and will discuss this with OCC Highways. A crossing in Benson Lane should be funded as part of the SODC office development.

Environment and recreation

A design for improvements to the pavilion facilities has been drawn up by Carrolls.

The playground, outdoor gym, pavilion, hard court and car park remain closed because of the coronavirus pandemic. The open spaces at Crowmarsh Gifford recreation ground and North Stoke Village Green are being well used for exercise following government rules.

Cllr Sherbourne reported that three flower tubs have been stolen from the Queen's Head roundabout.

Traffic and transport

The Chairman will meet the County Council officer Ralph Green on site to discuss the Parish Council's request for two bus shelters near the CABI site.

Correspondence

A North Stoke resident reported excessive activity on their private land by the river. Signs will be posted to remind people not to picnic or leave rubbish.

A petition with 17 signatures was received from an allotment holder, requesting a lockable tap at Botany Allotments. It was agreed that Cllr Sherbourne will liaise with the petitioner and arrange for a plumber to fit a tap and repair a leak in the water supply.
