Census 2021

The census, run by the Office for National Statistics, is a once-in-a-decade survey that gives the most accurate estimate of all the people and households in England and Wales. All households will be asked to take part in Census 2021 on 21 March.

This census will be the first to be predominantly online, with households receiving a letter with a unique access code to complete the questionnaire on a computer, phone or tablet. Paper questionnaires will be available if you need them.

The census results will be available within 12 months and will inform where millions of pounds of public funding is spent on services like cycle routes, schools and surgeries.

University of Oxford COVID study: appeal for volunteers

Over 50? Had a positive COVID-19 test with symptoms? Researchers need your help

People aged over 50 who have had a positive COVID test and are showing symptoms of the virus are being sought for research into helping them get better quickly.

Over-50s with certain underlying health conditions and all over-65s with suspected COVID-19 can apply to take part in the University of Oxford study at participating GP practices or www.principletrial.org.

Participants are randomly allocated to receive either usual care or usual care and an existing medication. It is hoped the trial can prevent people in these groups needing to go to hospital. Contact principle@phc.ox.ac.uk or call 0800 138 0880.

Participating GP practices include Wallingford Medical Practice and Mill Stream Surgery in Benson.

Benson Garden Club

On a cold, damp evening, February's Benson Garden Club Zoom talk made us think about, (and long for), hot summer days and how gardeners can prepare for this Summer and beyond.

Geoff Hodge gave a talk on "Gardening in dry and drought conditions – drought-resisting plants". He started the talk by pointing out that soil can dry out very quickly, meaning that conditioning your soil is an essential first step on the road to managing hot weather. Geoff recommended adding plenty of BOM (bulky organic matter) to retain nutrients and moisture, and then adding a 3"/7.5cm bark mulch (2"/5cm as a minimum) to top up your original BOM.

In terms of planting, Geoff advocated buying younger plants rather than being tempted by bigger, "instant impact", mature versions. As well as being cheaper, smaller plants are likely to develop their root systems more quickly. This, he explained is important because plants are only drought-resisting once they are well established with their roots down into the soil. So, for example, while Crocosmia "Lucifer" is drought-resisting once established, you will need to water it well for some time after it is first planted.

Geoff also advised on watering practices, with one thorough watering a week being better than damping down each day, in order to encourage the roots to follow the water down and grow deeper. Obviously, plants in containers still need to be watered more regularly.

Geoff then treated us to a wide range of drought-resisting plants to consider for our gardens, from different types of trees to shrubs, climbers, bulbs, herbaceous and bedding plants.

To help identify specimens likely to thrive in dry conditions, he pointed out what plant qualities tend to lead to drought resistance. For example, plants with waxy, scaly or hairy small leaves are better protected against the drying effects of strong wind or sun. Likewise, having silvery-grey leaves is another sign that a plant has drought-resisting properties.

By the end, we were thinking about how we might be able to spend more time this Summer looking at our garden from the comfort of a deckchair, rather than with watering can in hand!

Andrew Oldham will give our next talk, "The story of Dig for

Victory", on Thursday 4 March 2021. He will cover the history of the Second World War fight for food and why it is still relevant today.

Andrew is a disabled garden writer who has written for "The Guardian", "Sainsbury's Magazine" and the "Kitchen Garden". In 2010, after being made redundant from his job, he turned to "Dig for Victory" to help him convert his 1/4 acre garden to produce food to feed his family. In this talk, Andrew covers what he learnt whilst researching "Dig for Victory", including the common misconceptions and problems with digging to produce high yield food on a new plot.

Past Times

Killed by a sheep

On 23 February 1878, an inquest was held at the Swan Inn, Cholsey, on the body of 29year-old Alfred Shaw, the Station Master at Moulsford Railway Station.

Catherine Shaw, his widow, gave evidence that Alfred returned home from work at about ten past nine on Friday night, and said he'd had a hard day assisting loading sheep. One of the sheep refused to go into its railway truck and turned on him, butting him in the stomach and knocking him down.

She asked if he was hurt. He said he was only winded and he was able to carry on working until all the sheep were loaded and sent on their way to London. However, during the night she awoke and sensed something was wrong with her husband. She called her servant who struck a light, and they found her husband was dead.

Philip Pugh, a policeman at Moulsford Station, said the deceased was assisting in loading sheep into some 11 railway trucks bound for London. Each truck held 35 sheep, so it had taken most of the day. Nearly all the sheep were from Mr de Mornay's farm in Crowmarsh.

One of the sheep refused to go into the truck and butted Mr Shaw. He was struck by the sheep at 3.40pm and was able to work on until 5.30pm when he left to have his tea. He returned at 7.00pm and helped to finish loading the sheep. He left for home at 8.30pm.

Doctor Nelson examined the body and concluded that Alfred Shaw died from the rupture of a major blood vessel, probably by the sheep butting him in the stomach.

A verdict of "accidental death from the butt of a sheep" was returned. In Victorian times the number of deaths caused by horses, cows and pigs was very high, but being killed by sheep was quite rare.

Citizens Advice

When bills start piling up and multiplying, vague fears can turn into a paralysing panic for people experiencing money



troubles. Turn to Citizens Advice, with eighty years of experience in pulling people back from precipices. Your burden might seem overwhelming and impossible to resolve but in reality there is a lot you can do to turn things around.

Start by assembling your bills and make an overall list, with relevant details like dates when payment is due. Sort the bills into priority debts (rent and mortgage arrears, Council Tax, gas and electricity, tax and National Insurance – see https://www.citizensadvice.org/debt-and-money for a complete list) and non-priority debts (water rates – your supplier can't cut you off – credit cards, unsecured loans, hire purchase, etc).

Take the priority debts first and contact your creditors. Don't be afraid of this step. Many companies will be expecting you to get in touch, saying on the bill itself "We know that paying a bill can be difficult" or "Affected by Covid-19?" – and providing a telephone number or web link. Approach them with a constructive attitude, tell them you are actively tackling your debts, and perhaps ask them to suspend interest charges while you do so. They also might be amenable to letting you defer payment or pay smaller amounts over a longer time period. Ask about any special reductions – for example, the Warm Home Discount Scheme for electricity supplies (see www.gov.uk for more information).

If you need to compose a letter or email to a creditor, you don't have to start from scratch: copy or adapt a template letter from the Citizens Advice website. One especially useful letter asks creditors to give you more time.

If your circumstances have changed you might be able to claim benefits, or extra benefits. Citizens Advice runs a Help to Claim programme (call 0800 144 8444) and can guide you through all the stages. The Turn2us website at https://www.turn2us.org.uk will tell you what benefits you might be able to claim, and has details of grants for those on low incomes.

If you have an overdraft, talk to your bank. In the coronavirus age many banks are making

concessions and charging no interest on overdrafts up to a certain amount. Contact your district council about a possible Council Tax reduction. And think creatively about ways of increasing your income. Could you rent out a spare room in your house, for instance?

Talk to a volunteer at Citizens Advice (call Adviceline free on 0800 278 7907, Monday to Friday 9 am to 5 pm) or through webchat ("chat with us online about debt") Monday to Friday 8 am to 7 pm. Appointments in person are not available at present.

Local Transport and Connectivity Plan

Parish Council notes

Crowmarsh Parish Council met on-line on Thursday 4 February.

Present: Cllrs John Griffin, Stephen Sherbourne, Andrew Johnson, David Rowley, Ken McCrea, Robin Smith, Stuart Soames, Fleur Stevenson, David Topliss and Julian Park, Dr Yvonne Peet (Finance Officer), Mrs Sue Rance (Clerk), District Cllrs Sue Cooper and Andrea Powell.

An apology for absence was received from Cllr Liz Ryall.

District council matters

The heavy rainfall and prolonged high river level had once again led to flooding and sewer overflows in Retreat Gardens and at Bridge Villa Campsite. Following drainage problems at Newnham Farm requiring pumping out by tankers, a temporary diesel sewage pump has been installed. District Cllr Sue Cooper was following up on these and other local sewerage problems and had arranged a meeting with Thames Water to address all these issues in the near future.

A meeting would be held to discuss the future of the former SODC offices site following the recent survey.

Local elections are expected to take place on 6 May, and officers are working on the logistics planning needed to accommodate voting and vote-counting.

The Newnham Manor site was expected to come to planning committee in March but no date had been set. There have been details on conditions to be discharged (drainage strategy and arboricultural assessment), but the Parish Council is not consulted on these.

Finance

Donations were agreed of £200 to Sue Ryder Palliative Care Hub and £500 to Citizens' Advice South Oxfordshire.

Expenditure in January included salaries, refuse collection and the regular biomisting of the play equipment with Zoono, plus £1,440 for the preliminary design of a pedestrian crossing near The Bell. There will be consultation on this once a response has been received from Oxfordshire Highways.

Environment and recreation

The committee met on 18 January. Linda Parker was welcomed to the committee. Planning permission has been granted for improvements to the pavilion and building regulations approval will now be applied for.

Procedures for Covid management, including signage, have been reviewed. The parish council has taken precautions to make the area as safe as possible and the playground remains open, but will need time to dry out

following the recent heavy rain. The gym equipment is closed in accordance with government regulations.

If you do have to drive to the recreation ground, please park on The Street or use the Riverside car park, not in Bellamy Way, Access is needed for emergency services at all times.

Traffic and transport

Traffic management in North Stoke is a high priority to reduce speeding on Wallingford Road. Cllr Soames suggested action to slow traffic entering the village from the south. He and Cllr Sherbourne will work together to arrange a site meeting with an OCC Highways officer to consider the options. There is a requirement for a crossing in the planning approval for The Springs.
