

Can you help with COVID-19 vaccine research?

Could you join more than 1000 people in South Oxfordshire and sign up to be contacted about NHS COVID-19 vaccine studies you could take part in?

Anyone aged 18 and over can sign up to the NHS COVID-19 vaccine research registry at nhs.uk/researchcontact. Researchers will then contact those who sign up to ask if they wish to take part in vaccine studies that are due to open in their area.

There is no obligation to take part and you can withdraw at any time. Patient-facing healthcare workers and people from ethnic minorities are particularly needed to sign up, to help the NHS to ensure vaccines work for everyone.

Past Times55b The Street, Crowmarsh

The insurance office at 55b The Street has now closed and is about to become a private house. Denis Strange had a greengrocer's shop here for several years in the 1970s and 1980s.

Prior to Denis renting the shop, Anthony Lester ran an art business here. Between 1881 and 1911 Thomas Lovegrove was landlord of The Gardener's Arms. He was also a wheelwright and in the 1880s he used the building as a storeroom and workshop. Mr George Dunsden also used the building as a storeroom for building a business which he ran at least until the First World War.

In this photograph from 1912 the building next door is a three-storey building, the top floor of which was removed sometime in the 1920s. In 1937 this building (55a) was occupied by Joe Lay (Richard Lay's father).

From about 1840 until his death in 1847 John Brant was landlord of the beerhouse called the Coach and Horses (later the name was changed to The Gardener's Arms), and his son Henry who lived at 55a used 55b as his workshop to cast and sell clay pipes. When he married in the 1860s and moved to Wraysbury, his brother Edward took over and ran the clay pipe business until about 1872.

To go further back during lockdown is not easy, so I will finish at that stage.



Wallingford Country Market

As our regular customers will know, the Wallingford Country Market (usually held in St Mary-le-More Church each Friday morning) has been closed during spring and summer due to the COVID-19 pandemic.

The church remains closed, but we were very grateful at the end of September to have permission to use their pathway outside to set up a few stalls, selling home baked goods, preserves, honey, plants and eggs, while the weather was still fairly mild. The intention was then to move to Centre 70 off Goldsmiths Lane in November until the church re-opened.

We have traded very successfully from this prominent position outside the church for six weeks, but with another lockdown we felt we had to close again for November in order to keep both our producers and customers safe.

It is hoped that we will be able to trade from Centre 70, or the church if opened, for three weeks from Friday 4th December.

However, to keep in touch with some of our customers, we have a system for Christmas and other orders during December. If you would like to place an order, please contact one of the committee (listed below), who will pass your requirements on to the producers.

Items that can be ordered are: home-baked goods, preserves, local honey, home-grown winter bedding, flowering bulbs, hand-made Christmas wreaths and table decorations, home-crafted Christmas gifts and cards.

The producer will then get in touch with you to discuss your requirements and arrange collection. A small charge will be made if your order has to be delivered to you. We are living in uncertain times and can no longer plan too far ahead, but our producers will be pleased to perhaps ease things a little for our customers as Christmas approaches.

Wallingford Museum

Wallingford Museum's dedicated team of researchers are

working with an architectural model maker, Ben Taggart, to create a 1:300 scale model (1.5m x1.6m) of Wallingford's Royal Castle as it may have been in the mid-14th century.

This amazing collaboration draws on 15 years of research, unravelling the castle's history, using archaeology, geophysical surveys, LiDAR, maps, and transcription, translation and analysis of many documentary records. Some of these records, from the 12th to 19th centuries, also contain surveys with measurements, which greatly help the study.

Virtual meetings with Ben use all the available evidence to try to accurately position the walls, drawbridges, moats and buildings, such as the great hall, kitchens and stables, as they would once have looked.

The culmination of all this research will be a magnificent model of the castle at the height of its power, to share with everyone once the museum reopens in 2021.

In 2021 the museum will celebrate its 40th anniversary – created and entirely run by volunteers since 1981. We look forward to reopening in 2021.

Air quality in Crowmarsh

Letter received from a reader by email

Dear Editor

Have any of your readers noticed a significant deterioration in Crowmarsh air quality recently? It is very noticeable on still days (and evenings) when residents light their wood- or coal-burning stoves.

The imperfect combustion associated with such stoves releases toxic compounds into the air, including dioxins and polyaromatic hydrocarbons. These are compounds that make cigarette smoke carcinogenic. They can also trigger asthma attacks.

So please, Crowmarsh residents:

- If you intend to burn solid fuel in a woodburning stove, remember only do so when a strong breeze is blowing,
- Also take care to use only seasoned wood, or high-grade coal, to prevent thick smoke from hanging over the neighbourhood.

Please think of the environment and the health of your neighbours.

COVID-19 — plans for mass testing and mass vaccination

District Council officers are working intensively with other public sector colleagues from Oxfordshire County Council, Public Health England and the NHS to plan for mass testing and mass vaccination of the local population.

The situation remains fluid, with news about vaccines hitting our screens every day, but there is no scenario that does NOT involve local council staff playing a key role. Venues must be identified and secured, supply chain logistics resolved and resources engaged in order to carry out this huge effort if we are to meet the Government's targets.

When this preparatory work is added to the responsibilities of the Community Hub (see below), it is inevitable that some of SODC's "business as usual" activities will be

affected. All these new tasks are being taken on by existing staff, so if you have a query or a problem to raise with the Council it may take longer than usual to respond or resolve. Thank you for your patience, understanding and cooperation!

The Community Hub is still the main point of contact for individuals and families in need if local neighbourhood groups have not already provided support. They can put you in touch with a network of volunteer groups and organisations who can help with food and essential supplies. Crowmarsh playground

The Parish Council's Environment and Recreation Committee asks for your patience as they attempt to negotiate the everchanging government guidelines on enclosed spaces, play areas and outdoor gyms. As of now our understanding is that the play area can stay open with social distancing and hygiene, but the outdoor gym has had to close during lockdown and will only open if government restrictions allow after 2 December. The pavilion remains closed, but the playing field is available for outdoor exercise.

As well as providing hand sanitisers, every 25 days we have the play area and outdoor gym items fully sanitised with a surface protection understood to be effective against pathogens, viruses and bacteria.

The Committee would like to reassure residents that in the meantime they are doing their utmost to get the carousel and walker repaired and reopened.

Please note that 9am-10 am every day is reserved for shielding and vulnerable families. These could be vulnerable children with a parent/guardian, or a shielding/vulnerable adult with children.

The playground opens to everyone at 10am.



The Vicar writes...

Christmas is coming and nothing can stop it, so let us remember our hope as we prepare to celebrate the birth of Jesus. Amid all the uncertainties and

challenges of this year, our God remains constant and the Incarnation reminds us that God chose to be with us in our humanity with all the problems of this life. This brings us comfort and joy as it did to those facing different challenges 2000 years ago.

This year has been tough in many ways for so many people. Even our Sunday worship hasn't quite looked the same, but we hope to return to our COVID-safe worship again in December, including the 11am Christmas Day Festival Communion. On Sunday 27th December we will join the Wallingford Team at St Mary's 10am service to celebrate the feast day of St John the Apostle and Evangelist.

We are currently looking at alternatives to our traditional Carol Service and Crib Service, as congregational singing, close proximity and mixing of family bubbles must be avoided.

A pre-recorded Crib Service with contributions from children in Nativity costumes, readings and carols is looking favourite, so please contact me if your children would like to submit re-enactment video footage, with words from a provided script. We will need Mary, Joseph, inn -keeper, shepherds, angels, wise men, and also donkey, ox, sheep and camel.

Churches Together in the Wallingford Area hope to host "drive In" carol services in the car park of the Lidl supermarket after they close on Sunday evening 13th December, ideally with a family-friendly service first followed by a more traditional format, to make full use of the big screen. A booking system will be in place once we know that we can definitely go ahead.

Although we can't have our usual Crib Service, an Advent Trail around the village will have a new display each day, ending at the church lychgate on Christmas Eve. Thanks to all those decorating windows or creating a display in their front garden. The lychgate will also be decorated with a chain of hopes from children at Crowmarsh School, to complement our community's hopes made into decorations for the Christmas Tree at the school.

Whether we manage to worship together at some point or not, I pray that you and your families will be able to share a blessed and peaceful Christmas as we reflect once again on Emmanuel – "God with Us" and open ourselves to his comfort and joy.

John Howell MP writes...

So many different issues affect our health and well-being, as individuals and collectively, and we are acutely aware of this in our current circumstances. One of the key issues is our environment.

I have been very grateful this year to live in the rural setting that this constituency offers and have been particularly mindful of those who live in over-crowded urban situations. Being able to get out and walk in the countryside has been important to me in keeping fit and well. As I have walked over the months, I have enjoyed watching the changes in the landscape and been perhaps more conscious than in other years of the cycle of work for our farmers.

It is good news that the Agriculture Bill which has been progressing through Parliament this year has now passed into law. During the passage of the Bill some important changes were made particularly to tighten up on issues around the recognition of our farmers in food production and also on food security.

I believe that the Act is a good robust piece of legislation that sets the way forward, ensuring that our farmers are not undercut, and that the high quality of our food is maintained. It also sets out how farmers and land managers will be rewarded for the work they do towards protecting and encouraging wildlife, better air and water quality, and measures to reduce flooding. All of this contributes towards achieving the goals of the 25-Year Environment Plan.

I now look forward to the Environment Bill coming back to the House. This Bill is currently at the Committee Stage which is where a cross Party group of MPs scrutinise the Bill line by line. The Committee is due to report back by the beginning of December. The Agriculture Act has a specific focus on farming and land management and as such contributes towards wider environmental issues. The Environment Bill will put the environment at the heart of all policy making ensuring that this and future Governments are held to account on their wider environmental duties.

Just as the Agriculture Act set the Trade and Agriculture Commission in statute so the Environment Bill will establish the Office for Environmental protection. This will be an independent regulator which will scrutinise environmental policy and law, investigate complaints and take enforcement action when necessary.

The Government's 25-Year Environment Plan will also be placed on a statutory footing, and a set of environmental principles will be introduced that will be used to guide future government policy making. I know that developing a Nature Recovery Network is important to many. The 25-Year Environment Plan sets a commitment to this and a framework for Local Nature Recovery Strategies will be legislated for the Environment Bill. If you are interested in finding out more about these important pieces of legislation details can be found on the Parliament website: www.parliament.uk.

I am aware that this newsletter will appear in December publications. I hope that by then we will be out of lockdown and all able to look forward to a festive break that is something like the normal break we would take at the end of the year. It has been a difficult year in many ways, but I am optimistic that the tide will soon turn thanks to the wonderful work of our scientists who have thrown so much effort at vaccine research. However I know that for many families COVID-19 has taken the most dreadful toll and that loved ones are sorely missed all of the time and will be especially so during festivities. No words can ease that and I offer my deepest sympathies to all of you who face such loss.

Notes of the Parish Council Meeting held on Thursday 5th November 2020

Present: Cllrs John Griffin, David Topliss, Stephen Sherbourne, David Rowley, Ken McCrea, Stuart Soames, Fleur Stevenson and Andrew Johnson, County Cllr Mark Gray, Dr Yvonne Peet (Finance Officer) and Mrs Sue Rance (Clerk). Apologies were received from Cllrs Liz Ryall and Julian Park

The council co-opted Robin Smith as a new councillor for the North Stoke ward. We still have one vacancy and would welcome expressions of interest – please contact the parish clerk.

Report from the district councillors

COVID-19 support for individuals and families can be accessed via the SODC Community Hub (communitysupport@southandvale.gov.uk or telephone 01235 422600). Businesses are advised to check the website www.svbs.co.uk and sign up for regular newsletters.

A survey of residents' waste from random bins in selected streets will inform SODC how bins are being used and guide communication with residents about waste services.

The Inspector's final report on the SODC Local Plan 2035 is expected soon.

The council has been consulting on proposed changes to parking arrangements in off-street car parks, to make charging more equal and to encourage use of electric vehicles in order to reduce emissions (southoxon.gov.uk/parking).

SODC has responded robustly to the Government's White Paper on Planning Reform (https://www.southoxon.gov.uk/south-oxfordshire-district-council/planning-and-development/local-plan-and-planning-policies/external-planning-consultations-our-response/)

District Cllr Powell will be holding meetings about what is to be done with the former

council offices site and is keeping in touch with Crowmarsh, Wallingford and Benson Councils. Around 20 responses have been received to the consultation on the future of the site, which is printed again on page 4 – please do have your say, online or in writing.

District Cllr Cooper has been investigating with Thames Water sewage problems on and around the SODC site, where residual tanks are sited, as well as the water being pumped from the Bloor site into a ditch in Benson Lane.

Other planning matters

Work has begun on The Springs Golf Club development (P20/S1589/FUL). Plans for a pedestrian link to the footway along the B4009 have to be approved as a condition of the planning permission. Weekend working has been allowed in order to relocate bats before the end of October.

A tree preservation order has been confirmed on an oak tree at Blenheim Farm, Icknield Way.

Neighbourhood plan

A meeting was held with SODC officers and councillors on Friday 9 October. Nick Robins has incorporated many of the consultation responses and it is hoped that the plan can be submitted to SODC before Christmas.

Finance

Payments approved included £120 for biomisting with Zoono at the playground, £861.12 for dog bin emptying (July-September) and £1734 for grass cutting. It was agreed to increase the clerk's and finance officer's pay by 2.5% from 1 November, with a 5% rise for Chris Strange, who is working additional hours.

The audit report is awaited. The accounts for the year to date include £120,925 in Community Infrastructure Levy, to be spent on infrastructure projects, but this is capped so the council will receive no more for the year. It has to be spent within five years of receipt and will be considered in the budget for 2020/2021 at the December meeting, when the council will agree spending plans and set the precept, the amount that we receive via SODC from the

Council Tax. Operating income is considerably reduced because the pavilion has been closed.

A grant of £250 was agreed to Home-Start, which provides support for vulnerable families. Donations of £100 each were agreed to the Crowmarsh Gifford and North Stoke British Legion Poppy Appeals.

Environment and recreation committee

The outdoor gym and pavilion have had to be closed in line with government restrictions but the children's playground remains open. Biomisting treatment of the playground will continue until the end of March.

Planning permission has been granted for improvements to the pavilion. Ventilation improvements are being researched as well as the structural changes. The next step will be applying for building regulations approval.

Cllr Soames has stepped down from the committee. He was thanked for his hard work over many years. Mrs Linda Parker, a school governor and deputy churchwarden, will be coopted onto the committee.

Maintenance costs are increasing and a maintenance and replacement fund was suggested as a way to provide for this. The Finance Officer will consult SODC about the correct approach in accounting for this.

Cllr Sherbourne had a site meeting to discuss tree planting at the top of Park View: nearby residents will be consulted on this. Suggestions are welcomed for other tree planting locations.

Correspondence

Correspondence included a campaign against 5G phone installations and a report of motorcyclists using Watery Lane.


